<p>Article 3</p> <p>An employer whose the number of his workers in one place or within an area the radius of which is twenty kilometers, is exceeding fifty workers and less than two hundred, and in addition to his obligation to provide first aid kits, must employ a nurse holding a nursing certificate recognized by the Ministry of Health who shall be entrusted with rendering first aid treatment. The employer shall also appoint a doctor to treat workers at the place prepared by him for that purpose and shall give them medicines required, all free of charge.
